We are writing to you on behalf of Baring International Fund Managers (Ireland) Limited (the "Manager"), in its capacity as manager of the Unit Trust, to notify you of certain updates that are relevant to the Funds.

Clarification of Investment Policy / Compliance with Article 8 of the EU Sustainable Finance Disclosure Regulation (Regulation (EU) 2019/2088) ("SFDR")

It is proposed to update the investment policy in the supplement for each of the above named Funds to clarify that the Funds seek to promote environmental, social and governance ("ESG") characteristics within the meaning of Article 8 of the SFDR by investing or seeking to positively influence business practices to improve ESG characteristics. This clarification is for additional transparency purposes only and does not result in a change in the manner in which the Sub-Funds are managed.

As part of this update, the investment policy for each Fund will clarify that they respectively invest at least 50% of their total assets in equities of companies that exhibit positive or improving environmental, social and governance characteristics.
