# Changes to Investec Diversified Income Fund

### A sub-fund of the Investec Funds Series i OEIC

We are writing to you as an investor in the Diversified Income Fund (the "Fund"), to inform you about two important changes to the Fund:

- o The reduction of your annual management charge; and
- o The increase in the frequency of income distributions.

Please take the time to read this update carefully as it provides you with important information. Please note you are not required to take any action in relation to the changes.

# 01. Reduction in the annual management charge ("AMC")

We regularly review the fees charged across our fund ranges to ensure the ongoing charges remain appropriate and competitive. Following the latest review, we intend to decrease the AMC charged on the share classes in the Fund as follows:

This change will become effective on 1 October 2015.

# 02. More frequent distributions of income

Due to the continuing low interest rate environment and new UK pension freedoms, we are aware that our investors could benefit from receiving more regular income from their investments. Therefore, we have decided to increase the frequency of the Fund's income distributions to you, from quarterly to monthly.

Income distributions will take place on the last business day of each calendar month. Your last quarterly payment will be paid in November 2015. The first monthly distribution payment will start in December 2015.



For accumulation shareholders, distributable income will continue to be accumulated in to the value of your shares.

This change will become effective on 5 October 2015.

# Do you need to take any action?

You are not required to take any action in relation to the changes detailed in this update. These changes will not change the ISIN, Sedol or any other codes associated with your share classes.
