Dear Shareholder,

We write to you in your capacity as shareholder of the Company, an investment company with variable capital – specialised investment fund (société d'investissement à capital variable – fonds d'investissement spécialisé, SICAV-SIF) subject to the Luxembourg act dated 13 February 2007 on specialised investment funds, as amended (the SIF Act 2007).

You have been convened the 2nd of June 2021 to an extraordinary general meeting of the shareholders of the Company (the **First Meeting**), whose purpose was to resolve on the voluntary liquidation of the Company.

Whereas the First Meeting was not in a position to validly deliberate and vote on the proposed agenda since the quorum prescribed by articles 450-3 (2), 600-2 and 1100-2 of the Luxembourg act of 10 August 1915 on commercial companies, as amended (the **1915 Act**) was not reached. Therefore, you have been convened the

24th June 2021 to a second extraordinary general meeting of the shareholders of the Company (the **Second Meeting**) to resolve on the voluntary liquidation of the Company.

You are hereby informed that the Second Meeting which was to be held on 28 July 2021 at 11:00 am (Luxembourg time) at the registered office of the Company was cancelled by the Luxembourg Notary for reasons beyond the control of the General Partner. Indeed, the Luxembourg Notary noted some discrepancies between the power of attorneys received and the shareholder's register.

Against this background, you are hereby convened to the second postponed extraordinary general meeting of the shareholders of the Company (the **Second Postponed Meeting**) to be held at the registered office of the Company, 75 Parc d'activités, L-8308 Mamer/Capellen, Grand Duchy of Luxembourg on Thursday 26 August 2021 at 11:00a.m. (Luxembourg time) having the same agenda as the First and Second Meetings, as set out below and in the power of attorney attached hereto as **Appendix 1** (the **Power of Attorney**).

Please note that in accordance with articles 450-3 (2) and 1100-2 of the 1915 Act, the Second Postponed Meeting will validly deliberate regardless of the proportion of the capital represented at the meeting. However, the resolutions, to be adopted, must be carried by at least two-third of the votes.

Votes relating to shares for which the shareholder did not participate in the vote, abstain from voting, cast a blank (*blanc*) or spoilt (*nul*) vote are not taken into account to calculate the above majority requirement. Each share of the Company is entitled to one vote.

The agenda of the Second Postponed Meeting is as follows:

- (a) appointment of chairman of the Meeting;
- (b) decision to dissolve the Company and to voluntary put the Company into liquidation (*liquidation* volontaire) with immediate effect (the **Liquidation**);
- (c) decision to appoint ME BUSINESS SOLUTIONS S.à.r.l., a private limited liability company (société à responsabilité limitée) incorporated under the laws of the Grand Duchy of Luxembourg, having its registered office at 16, rue Jean-Pierre Brasseur, L-1258, Luxembourg and registered with the Luxembourg Trade and Companies Register under number B142063, represented by Mr Eric Chinchon, as liquidator of the Company (the **Liquidator**);
- (d) acknowledgement that the Luxembourg regulator of the financial sector, the *Commission de Surveillance du Secteur Financier* (CSSF), issued a non-objection letter with respect to the appointment of the Liquidator as voluntary liquidator of the Company;
- (e) decision to (i) confer to the Liquidator the broadest powers set forth in articles 1100-4 et seq. of the Luxembourg act dated 10 August 1915 on commercial companies, as amended (the Companies Act); (ii) authorise the Liquidator to execute all deeds and carry out all operations, including those referred to in article 1100-5 of the Companies Act, without the prior authorisation of the general meeting of the Shareholders; (iii) authorise the Liquidator to delegate, under its own responsibility, its powers, for specific operations or task, to one or several persons or entities; (iv) empower and authorise the Liquidator, on behalf of the Company in liquidation, to execute, deliver, and perform the obligations under, any agreement or document which is required for the liquidation of the Company, the discharge of its liabilities and the disposal of its assets and (v) authorise the Liquidator to make advance payments of the liquidation proceeds (boni de liquidation) to the Shareholders, in accordance with article 1100-9 of the Companies Act;

You are informed that you may participate to the <u>Second Postponed</u> Meeting by way of video conference in accordance with article 21.4 of the articles of association of the Company. You may therefore either be represented in person on the basis of a power of attorney or participate to the <u>Second Postponed</u> Meeting by way of video conference.
