Janus Henderson Horizon Fund (the “Company”): Restructuring of J.P. Morgan Bank Luxembourg S.A. (the “Securities Lending Agent”) into J.P. Morgan SE

Dear Shareholder,

As part of the implementation of J.P. Morgan's legal entity strategy within Europe, the current Securities Lending Agent for the Company (J.P. Morgan Bank Luxembourg S.A.) merged into J.P. Morgan A.G., which at the same time changed its legal form from a German limited company (Aktiengesellschaft) to a European Company (Societas Europaea) (the “**Merger**”). As a result of the Merger, the new securities lending agent, as disclosed in the prospectus, became **J.P. Morgan SE** with effect from 22 January 2022 (the “**Merger Date**”).

J.P. Morgan Bank Luxembourg S.A. and J.P. Morgan AG (which at the Merger Date will change its legal form to J.P. Morgan SE) are members of the J.P. Morgan group of companies.

The Merger and the thereto related change of entity acting as Securities Lending Agent for the Company (i.e., from J.P. Morgan Bank Luxembourg S.A. to J.P. Morgan SE), does not entail a change to the scope or terms of the securities lending services provided to the Company. Further, there will be no additional costs resulting from such Merger. Therefore, there is no impact on any of the Company's operational processes, nor is there any impact on the way the Funds are managed, and no impact for Shareholders.

The Prospectus will be updated as soon as reasonably practicable to reflect this change. **You do not need to take any action in response to this notice.**
