



## INVESTOR NOTICE

10 June 2022

Dear Investor / Creditor,

We have been advised by a number of investors that they have received an email seeking information from them and providing a website address purportedly relating to the Kijani Commodity Funds, which are the segregated portfolios of Brighton SPC, a Cayman Islands company that is in our control as liquidators, as well as Kijani Resources Limited ("KRL") and Ratio Limited ("RL"), both Gibraltar companies that are in our control as liquidators. This communication is not from the KRL, RL or Brighton SPC's liquidators and we did not consent, or have prior notice of it. We now understand that this has been sent by Simon Hooper, a former director of KRL and RL. We did not provide investors' contact information to Mr. Hooper to facilitate this communication.

As you may be aware, Mr. Hooper and other ex-Directors, Richard Fagan and William Redford, are the subject of a very substantial legal action initiated by us as liquidators of KRL and RL under the Gibraltar Insolvency Act for, amongst other things, alleged Fraudulent Trading, Insolvent Trading and breach of the fiduciary duty. We initiated this legal action last year after taking legal advice and consultation with the Liquidation Committee. It is worth mentioning that in the pleadings we recite that Mr. Hooper pleaded guilty in the UK to three counts of fraud relating to another matter, Rationale Investments Limited, and has been disqualified as a director there for 2 years effective 2 March 2021.

Accordingly, we recommend that investors treat Mr. Hooper's email correspondence and link with the utmost caution and do not provide any personal information in response. We will be writing to Mr. Hooper in relation to his communications and asking him what information he is still holding in respect of investors and highlighting his obligations not to misuse personal information. We are also taking legal advice in relation to the statements and information he has included in his communication and website.
