In the interim, the Joint Official Liquidators are aware that the Company's records in their possession are incomplete and are keen to ensure that they are able to communicate with all investors, creditors and shareholders. In this regard, the Joint Official Liquidators reiterate their previous requests that, where this letter is received by any third party, nominee, custodian or party to which there are underlying investors with an economic interest of the outcome of the Liquidation of the Company, that this letter is forwarded on to the relevant persons accordingly.
