Update on the integration of Legg Mason and Franklin Templeton

Dear Business Partner,

We are writing to you in relation to the re-branding of the Legg Mason Global Funds plc (“**LMGF**”) and Legg Mason Global Solutions plc (“**LMGS**”) Ireland-domiciled fund umbrellas.

We have notified shareholders of the proposal to change the name of the fund umbrellas, from Legg Mason Global Funds plc to **Franklin Templeton Global Funds plc**, and from Legg Mason Global Solutions plc to **Franklin Templeton Global Solutions plc**, by way of a special resolution at the LMGF and LMGS Annual General Meetings on 25 November 2022 and 9 December 2022, respectively. We can now confirm that the special resolutions were passed at each of LMGF and LMGS Annual General Meetings.

Additionally, the board of directors approved the proposal to change the names of certain sub-funds of LMGF and LMGS, as set out in Appendix A of this letter, to reflect the relevant new fund umbrella name. These changes will not impact the fund identifier codes that we use for the LMGF and LMGS sub-funds, such as the ISIN and CUSIP codes. The change of names will not affect contracts, including distribution agreements, made between our companies that relate to the distribution of LMGF and LMGS sub-funds. For the avoidance of doubt, such distribution agreements will not change in manner or subject and the LMGF and LMGS sub-funds being traded, sold, and held by you or your clients will not change from a legal perspective on the basis that these updates merely reflect a change of name.

The name changes as set out in Appendix A will take effect on, or around, 21 February 2023, subject to the approval of the Central Bank of Ireland, or such later date as may be notified to shareholders of LMGF or LMGS via our website.

All costs associated with the name changes are being borne by Franklin Templeton.



Update on the integration of Legg Mason and Franklin Templeton

Dear Business Partner,

We are writing to you as an intermediary of a shareholder, or shareholders, invested in one or more of the sub-funds of the Legg Mason Global Funds plc ("**LMGF**") and/or Legg Mason Global Solutions plc ("**LMGS**"), Ireland-domiciled fund umbrellas.

Franklin Templeton completed its acquisition of Legg Mason on 31 July 2020. We would now like to confirm the next stage of the integration.

We have written to shareholders with a proposal to change the name of the fund umbrellas, from Legg Mason Global Funds plc. to **Franklin Templeton Global Funds plc**, and from Legg Mason Global Solutions plc to **Franklin Templeton Global Solutions plc**.

Shareholders have been asked to vote on these proposals, by way of a special resolution at the respective LMGF and LMGS Annual General Meetings on 25 November 2022 and 9 December 2022, respectively.

Additionally, it is proposed to change the names of certain sub-funds of LMGF and LMGS as set out in Appendix A of this letter to reflect the relevant new fund umbrella name. These changes will not impact the fund identifier codes that we use for the sub funds such as the ISIN and CUSIP codes.

The name changes as set out in Appendix A will take effect on, or around, 21 February 2023, subject to the approval of the Central Bank of Ireland, or such later date as may be notified to shareholders of LMGF or LMGS via our website.

All costs associated with the name changes are being borne by Franklin Templeton.
