INTRODUCTION

We are making some changes to the Funds. These changes will happen on 14 July 2023.

You do not need to take any action and the Funds remain open for the issue and redemption of shares as normal.

Appendix 1 lists the Funds affected by these changes. Not all Funds listed in Appendix 1 will be affected by all changes in this letter, please read the “Details of Changes” section below to confirm which Funds are affected by each change.

DETAILS OF THE CHANGES

We are making the following 6 changes:

1. Reduction in the Annual Management Charge (“AMC”) for Class A Shares of the FSSA Greater China Growth Fund:

We will reduce the AMC for Class A Shares of the FSSA Greater China Growth Fund as follows:

Share Class	Current AMC (as a % of the Fund’s Net Asset Value) per annum	AMC with effect from 14 July 2023 (as a % of the Fund’s Net Asset Value) per annum
Class A	1.75%	1.50%

2. Reduction in the AMC for Class A and Class B Shares of the Stewart Investors Global Emerging Markets Leaders Fund:

We will reduce the AMC for Class A and Class B Shares of the Stewart Investors Global Emerging Markets Leaders Fund as follows:

Share Class	Current AMC (as a % of the Fund's Net Asset Value) per annum	AMC Charge with effect from 14 July 2023 (as a % of the Fund's Net Asset Value) per annum
Class A	1.45%	1.30%
Class B	0.80%	0.65%

3. Removal of Conversion requests by phone from the Prospectus

The registrar, Bank of New York Mellon, do not offer conversion requests by telephone. We will therefore remove this from the Prospectus. This change will affect all Funds listed in **Appendix 1**.

4. Clarification of the AMC calculation methodology

In order to better articulate the process, we will update the language we use to describe how the daily AMC accrual is calculated. We currently describe this calculation as being based on the current Dealing Day's Net Asset Value. We will amend this description to "the prior Dealing Day's Net Asset Value, taking into account any subsequent changes due to the creation or cancellation of shares". The updated description maintains fair treatment of shareholders by ensuring the daily AMC accrual is closely aligned with the Class Net Asset Value on which it is based. The rate of the AMC is unaffected. This change will affect all Funds listed in Appendix 1.

5. Clarification of Non-Dealing Day and Business Day

We will clarify how we describe a "Dealing Day" and a "Business Day". We will also include "Non-Dealing Day" as a defined term in the Prospectus to help better ensure transparency and clarity of meaning. This change will allow us to provide additional clarification regarding (a) the impact of Non-Dealing Days on the settlement of investor transactions; and (b) days on which assets of the Fund will not be tradeable. These changes will affect all Funds as detailed in Appendix 1.

6. Removal of Class E Regular Saver Feature

Currently we offer a regular saver feature to Class E shareholders of the below-listed Funds. We will remove this feature because these shares are marketed to institutional clients.
