Please note that the following German Funds will be subject to the changes outlined with effective date as of **September 29<sup>th</sup> 2023**. Details can be found in the excel file attached.

Among them, funds that are NOT compliant to BaFin exclusion criteria, namely Allianz Interglobal, Allianz Vermögensbildung Deutschland, Allianz Vermögensbildung Europa, Allianz Wachstum Euroland, Allianz Wachstum Europa, and Industria, are Not allowed to be marketed as sustainable.

**Please note that in their cover mails providing the BaFin approval, BaFin has explicitly mentioned that they may take action against AllianzGI if they have indications for a distribution of the fund as sustainable. This statement is resulting from the fact that the fund does not comply with BaFin exclusion criteria. Hence, we need to ensure in our distribution activities and marketing communication that this fund is not marketed as sustainable.**
