Notice is hereby given to the shareholders of the subfund "**Credit Suisse (Lux) CommodityAllocation Fund**" (the "**Subfund**") that Credit Suisse Asset Management LLC acting as Sub-Investment Manager of the Subfund will be replaced by UBS Asset Management (Americas) LLC, as a consequence of the recent acquisition of Credit Suisse by UBS. This change will take effect on 1 May 2024. The Prospectus of the Company will be updated within 3 months. The appointment of UBS Asset Management (Americas) LLC as Sub-Investment Manager of the Sub-fund is covered by section 16 of the Prospectus according to which the Investment Manager may appoint, under its responsibility and control and at its own cost, affiliates within the UBS Group as sub-investment managers.

For the avoidance of doubt, such change will not result in any change to the applicable fees nor to the investment policy of the Subfund.

Capitalised terms used in this notice but not defined herein shall have the meaning ascribed to them in the Prospectus dated 23 January 2024 and the Articles of Incorporation dated 20 September 2018.
