IMPORTANT INFORMATION - FUND CHANGES

Dear Investor,

abrdn OEIC IV and VI Funds (the Funds)

Please read this letter carefully as it contains important information regarding upcoming changes to the above Funds and any action you may need to take for future transactions. We would encourage you to familiarise yourself with the changes.

In this letter, when we say 'we' or 'us', we mean abrdn Fund Managers Limited, the company that is currently responsible for managing and operating your investment.

For trades placed on and from 7 October 2024 we will be making a change to the times for dealings in the Funds (including buying and selling shares). This is to assist in ensuring any regulatory impact to the Funds is minimised following changes to the trade settlement timelines which have taken place in some countries the Funds invest in (such as United States of America and Canada). These changes mean the Funds have to make payments when they buy investments and also receive the proceeds when they sell investments sooner than they currently do. To align with the shorter payment cycle for investments, we will be reducing the settlement period for the Funds from the existing trade date (i.e. the date on which you place your order for subscription, redemption, switch or conversion) plus 3 business days (T+3) to trade date plus 2 business days (T+2). That means, for example, when you buy shares, we need to receive the payment from you within 2 business days, and when you sell shares, we will pay the proceeds to you within 2 business days. These timescales were previously 3 business days. There are no other changes to the way we manage your investments.
