**Notice to investor in the I share classes of the Franklin Templeton Investment Funds –  
Franklin Global Convertible Securities Fund**

Dear Shareholder,

The Franklin Global Convertible Securities Fund (the “Fund”) has been closed to subscriptions received from new and existing investors since December 9, 2020, and until further decision of the Board of Directors (the “Board”). This is because the Fund’s capacity has been constrained largely due to weak new convertible bond issuance trends in recent years which limited the size of the overall convertible securities universe.

As issuance trends have shown signs of improvement, the Board has decided to re-open certain share classes of the Fund to subscriptions from existing investors in those share classes. Since there will be limited capacity available, investors wishing to subscribe must (i) notify by email to [TAOversightLux@franklintempleton.com](mailto:TAOversightLux@franklintempleton.com) the amount they wish to invest by 28th October 2024 and (ii) invest within the re-opening period. Should the sum of the intended subscriptions exceed the capacity available, the limited capacity will be shared across the investors in proportion to the amounts they wish to invest.

Investors meeting the deadline, with firm commitments, will be notified of their allocation and be allowed to place orders corresponding to that allocation within the re-opening period. Investors who did not meet the deadline will not be able to invest during the re-opening period.
