Portfolio Management has historically believed that depending on the issuance environment and pace of flows the Fund's capacity is limited given our preference for sourcing investments from the primary market. Although convertibles issuance trends have been strong; having evaluated a number of factors, we believe it is prudent to slow the growth of new assets into the Global Convertibles strategy to protect our ability to effectively manage assets for our existing investors.

## 1. What does "soft close" mean?

Yes, existing investors are entitled to switch their existing holdings to an alternative share class and/or buy an alternative share class provided the minimum criteria is met.
